Ralston City Council Regular Meeting Tuesday, January 15, 2019

The Ralston City Council met in regular session on Tuesday, January 15, 2019 at 5:30 PM at Ralston City Hall. The Pledge of Allegiance was recited. Roll was called with the following present: Mayor Groesser and Council members Konwinski, Fideline, Kavanaugh, and Krause. Council members Sanchez and Preis were absent. The agenda was available at City Hall for public inspection and posted prior to the meeting. The legal notice for the meeting was published in the Ralston Recorder. Claims listed are approved and part of these minutes.

Pastor Matt Fowler, Trinity Methodist Church, gave the invocation. Mayor Groesser welcomed the press and guests. Groesser said the meeting is subject to the Nebraska Open Meetings Act and a copy of the Act is posted at the rear of the Council Chambers.

Benis reported on future events: George Thorogood, Travis Tritt, and Lil Baby.

Benis has been in negotiations with Ren Smith from the Omaha Sports Commission, for the 3 on 3 basketball league, a FIBA sanctioned event. This will be an Olympic competition in 2020 and they are hoping to be Omaha-based. Benis said this is in the early stages but he is excited about this.
