

### When Do You Need a Building Permit?

For many different types of home repair and improvement jobs, permits are required. Though simple repairs usually don't require a permit, additions or major changes usually do require that you get the appropriate permit.

If your project involves minor cosmetic surgery, you probably will not have to worry about getting a building permit. If you are making changes to your house's structure, plumbing, or electrical wiring, a permit **IS REQUIRED**. If in doubt, please call City Hall at 402-331-6677.

Once you have received a permit, it's important to ensure your permit is finalized when the work is complete. A final inspection of your project by the City is required in most cases. Call City Hall to schedule an appointment with the building inspector.

### **Baright Library News**

The library has had a fantastic year, and the numbers show it! You can see just how much the community enjoys the library through the statistics we collected from this past fiscal year, October 2017 through September 2018.

Library materials, whether they are electronic or print, circulated over 78,000 times last year. Adults checked out about 39 percent of that total, and children checked out another 31 percent. The final third of the pie included eBooks, computer use, and teen materials checkouts. Our current collection at the Baright Public Library includes over 45,000 items for the public to browse and check out! We keep the materials on the shelf as fresh as we can by rotating in and out about 3,500 materials each year. Looking at the number of visits that occurred last year, we saw 73,876 people come in throughout our open hours. We had nearly 4,000 more visits than two years ago! More than 225 people on average visit us on a daily basis at the library, whether that's to check out materials, attend an event, or use the computers to apply for a job. Our two free reservation meeting spaces saw 8,236 visitors on their own.

Library visitors frequently use the computers to access the Internet. Nearly 18,000 computer uses were recorded this past year, not including the 5,162 uses of the children's educational gaming computers. Staff logged 137 one-on-one instructional sessions with those seeking technology assistance.

We enjoyed spending time with each and every one of you in the Ralston community at special programs throughout the year. Staff took pleasure in each opportunity to connect and serve you all, whether it was through the summer Lunch Truck, story times, school book clubs, adult educational programs, or volunteering.

We hope you continue to visit us! We are open to the public seven days a week with 62 total open hours and 24/7 access to our electronic library as well!

### **Eagle Scout Projects in Ralston**



James Strabala, Boy Scout Troop 359

On October 23, 2018, James Strabala presented his completed Eagle Scout project to Mayor Groesser and Council member Craig Alberhasky. James constructed bat houses. He chose this project because he thinks that bats are interesting and their numbers are declining. A single bat can eat about 5,000 insects in a night and over time can save thousands of dollars in pest control. The bat houses are 26 inches tall and 24 inches wide and 2 inches deep and will hold about 50 bats. The City will hang the bat house in Wildewood Park and Alberhasky plans to hang his bat house at his home.



Tyler Richards, Boy Scout Troop 282

Tyler Richards' year long Eagle Scout project was dedicated on November 1, 2018. Tyler's project is a tribute to first responders in Koch Park consisting of a firefighter, police officer and EMT. Tyler started planning the project in late 2017 and sold flags, first aid kits and battery packs to help reach his fund-raising goal of \$19,000. Tyler was also able to find sponsors to help fund the statues. The concrete work was donated and Tyler received discounts on wood for the benches. Tyler's fundraising efforts exceeded his goal and he plans to put the extra money aside into a fund to help with maintenance costs for the project.

## Ralston's Winter Weather Ordinances

Winter is here and with it comes ice and snow. Be a good neighbor and make sure that after a winter storm you clear your sidewalk.

The following are some of the applicable ordinances regarding snow. For more detailed information, the Ralston Municipal Code is available in its entirety on our website, at City Hall or at Baright Public Library.

**Sidewalks; Kept Clean (Sec. 8-201)** - It is the legal responsibility of the occupant or the owner of any property to keep the sidewalks clear of snow, ice, mud, etc. Sidewalks within residential neighborhoods shall be cleared within 24 hours after the end of the weather event. In business districts, sidewalks should be cleared within 5 hours from the end of the storm or by 8:30 am if the storm ended overnight.

Parking-Designated Snow Emergency Routes (Sec. 5-624) - All designated snow routes are marked with permanent signs. These streets will be cleared first by the City of Ralston.

Parking-After Declaration of Snow Emergency (Sec. 5-625) - When the Mayor declares a snow emergency, the news media is notified. It is illegal to be parked on any designated

snow emergency route beginning at the stated time until 24 hours after the snow ends or until the accumulated snow has been plowed to the curb on both sides of the street, whichever is sooner. Any automobile parked on a snow emergency route is in violation of this section and may be ordered to be removed by the Ralston Police. If the vehicle is not removed or it's presence makes it impossible to plow the snow, the person is in violation and shall be civilly liable to the City of Ralston for any added plowing expense incurred as a result of the illegally parked vehicle.

Parking-Snow Emergency Route Violation (Sec 5-627) - In addition to the removal of the vehicle and civil liability imposed, the owner of any vehicle parked in violation of these sections shall be deemed guilty of a misdemeanor and subject to penalties.
